6 SEC. 2. SENSE OF CONGRESS.

1 (1) shared international development coopera-2 tion between the United States and Israel benefits 3 the development efforts of the United States through 4 the sharing of Israel's unique expertise as seen in 5 the work done by Israel's Agency for International 6 Development Cooperation (MASHAV) as well as 7 Israel's humanitarian programs and robust civil soci-8 ety sector;

9 (2) since the signing of a memorandum of un-10 derstanding for global development cooperation be-11 tween the United States Agency for International 12 Development and MASHAV on August 21, 2019, 13 the United States and Israel have collaborated on a 14 number of initiatives in Africa, Eastern Europe, and 15 Latin America across such sectors as water tech-16 nology, agriculture, and education;

17 (3) this ongoing cooperation harnesses the 18 strengths of the United States and Israel in carrying 19 out projects in developing countries and dem-20 onstrates the shared commitment of both the United 21 States and Israel to international development, 22 thereby furthering the policy of the United States to 23 expand prospects for engagement and normalization 24 between Israel and other countries; and
